Promotion Terms and Conditions

TERMS AND CONDITIONS

The promotion name is the WPH Sports Club's Footy Tipping Competition 2021. The promotion is authorised under NSW Permit No TP/000763

1. The promoter is West Pennant Hills Sports Club Limited ABN 50 000 609 450.
2. Entry is open only to current financial members of West Pennant Hills Sports Club Limited and staff currently employed by West Pennant Hills Sports Club Limited.
3. All prizes are set as per these Terms and Conditions and will not be altered.

Promotion Period

4. The promotion will commence on Thursday 11 March 2021 and will end after the last round match is played in each of the national NRL and AFL competitions.

Promotion Entry

5. To enter this promotion, members must register with ESPN Footy Tips and join the WPH Sports Club Competition. A direct link to the site is provided at www.wphsportsclub.com.au/sports/footytipping
6. It is the responsibility of the member enter their weekly tips on the ESPN site before the commencement of the first round of each code each week.

Promotion Mechanics

7. Members can enter or edit tips for each game at any time prior to the nominated game commencement times as published on the ESPN website.
8. Under no circumstances will tips be accepted after a game has commenced.
9. If a member fails to enter tips for a game or round will be awarded the lowest competition score.
10. Should a member get all tips correct in a round (per code) they will be awarded 2 additional points.
11. Tippers on the same score will share the same ranking.

Prize Details

12. A total prize pool of \$6,000 will be won in the 2021 Tipping Competition.
13. First prize in each code will be \$2,000
Second prize in each code will be \$750
Third prize in each code will be \$250
14. Should 2 members be on equal top points at the conclusion of the competition, the value of first and second prizes will be pooled and divided equally between the two members. In this case, no third prize would be awarded.
Should 3 or more members be on equal top points at the conclusion of the competition the value of first, second and third prizes will be pooled and divided equally between these members. In this case no second or third prize will be awarded.

Should or more members finish in second place, the value of the second and third place will be pooled and divided equally between these members. In this case no third prize will be awarded.

General Terms and Conditions

15. The Club reserves the right not to accept any registration (i) for any Participant if the registration contains anything defamatory or is otherwise offensive or inappropriate in any way, as determined by the Promoter in its absolute discretion, or (ii) any registration that the Promoter reasonably suspects have been created using a computerised scripting tool.
